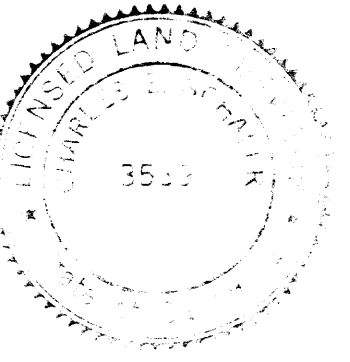

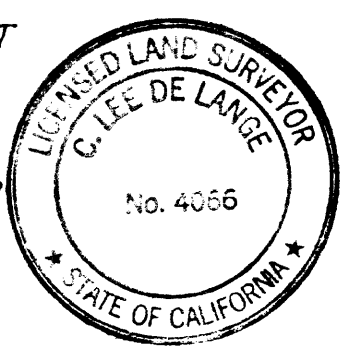
PORTION OF PARCEL A OF 13-M-70 AND A
